**Meeting Minutes:**

**1. Call the Meeting to Order**

J. Hackworth called a special meeting of the Board of Directors of ReGeneration Schools to order on Tuesday, July 29, 2025 at 4:15 pm ET.

**2. Public Comment**

There was no public comment

### 3. Operations Update

ReGen's CEO, S. Harvey, provided operational updates on transportation

Transportation

- ReGeneration Schools Ohio will provide private transportation services via First Student beginning with the 2025-26 school year
- ReGen scholars who take CPS buses have a chronic absenteeism rate 13.64% higher than those who get to school by other methods (supp. transportation, parent/guardian transportation, etc.)

### 4. Resolutions

#### Assuming Transportation Services

Ohio Revised Code Section 3314.091 permits community schools to assume the responsibility to provide transportation for any student who was enrolled in the school and was also a native student of the district in which the student resides.

- Assume the responsibility of providing transportation to students who are enrolled at ReGeneration Bond Hill, ReGeneration Avondale, and ReGeneration Middle School, and are also native students of the districts beginning with the 2025-2026 academic year and continuing until relinquishments and assumptions thereafter;
- Authorize Lori Flood to notify the districts and the Ohio Department of Education and Workforce Pupil Transportation Office of ReGeneration Bond Hill, ReGeneration Avondale, and ReGeneration Middle School's decision to assume transportation responsibilities in writing, and approve and ratify his/her actions, including any notice which occurred before the date of these resolutions;
- Approve, adopt, and ratify Policy 236 - Transportation of Pupils and Policy 236.1 – Emergency and Evacuation Procedures;
- Authorize and direct the school's operator to identify and contract with an appropriate pupil transportation provider in order to effectuate this resolution.

R. Blackwell made a motion to approve and adopt the transportation resolution noted above for ReGeneration Bond Hill, ReGeneration Avondale and ReGeneration Middle School. L. Moses seconded the motion.

4 votes in favor, 0 opposed, 0 abstained = **The board VOTED to approve the motion.**

**NOW THEREFORE**, in a public meeting duly noticed and held on July 29, 2025, a majority of a quorum of the Governing Authority passed the following resolution:

**RESOLVED**, the Governing Authority assumes the responsibility of providing transportation to students who are enrolled in the School and are also native students of the Districts beginning with the 2025-2026 academic year and continuing until relinquishments and assumptions thereafter;

**RESOLVED**, to authorize Lori Flood to notify the Districts and the Ohio Department of Education and Workforce Pupil Transportation Office of the School's decision to assume transportation responsibilities in writing, and approve and ratify his/her actions, including any notice which occurred before the date of these Resolutions;

**RESOLVED**, to approve, adopt, and ratify Policy 236 - Transportation of Pupils and Policy 236.1 – Emergency and Evacuation Procedures; and

**RESOLVED**, to authorize and direct the School's operator to identify and contract with an appropriate pupil transportation provider in order to effectuate this resolution.
