 - a. ReGen Bond Hill Ohio State Test
 - i. Preliminary math results The pandemic's impact on math achievement was particularly large for Black students in Ohio, in Cincinnati, and in Bond Hill
 - ii. ReGen more than doubled proficiency and reduced the percentage of students scoring "limited" by 50%

- b. NWEA MAP Growth: Math and Reading Response to Data
 - i. Instruction:
 - 1. Focus on grade level instruction and not remedial content
 - 2. Provide "just in time" lessons from previous grade level standards that are the foundation of current grade level standards
 - 3. Continue weekly data meetings to address gaps in learning
 - 4. Continue small group tutoring based on standards and internal assessments
 - 5. Augment small group with targeted individual support

ii. Talent

- 1. Ensure strongest teachers are in 3rd & 4th grade along with enhanced grade level stipends for those grades
- 2. Returned to in-person interviews and hiring this year to ensure mission fit, model fit, and receptivity to feedback
