1. Call the Meeting to Order

M. Wallace called a meeting of the board of directors of ReGeneration Schools to order on Monday, April 15, 2024 at 4:48 pm ET.

2. Public Comment

There was no public comment

3. CEO Opening

ReGen's CEO, S. Harvey, gave an update and reported on the state of ReGeneration Schools highlighting the following:

- Wins: hired a Chief of Staff; FY25 balanced budget
- Challenges: hiring; culture; retention; enrollment
- Priorities: ELA and math growth; staff retention and recruiting; student retention and enrollment; student joy

4. Introductions

ReGen's new Chief of Staff, A. Montagna, was introduced to the board

5. Academic Report

ReGen's CEO, S. Harvey, shared academic priority updates highlighting the following:

- Response to data Weekly PPQs (weekly "mini mock" ELA & math state tests, weekly data meetings, targeted MTSS blocks, interim assessments and data days used to create data-driven plans, and guided reading training
- Culture focus on SEL / positivity project, consistent systems & routines, and community circles and morning meetings
- Professional development real time coaching and modeling in the moment with 90 minutes of weekly PD every Friday focusing on skill building, lesson rehearsals and time for family engagement

6. Operations Update

ReGen's COO, L. Flood, provided operational updates highlighting the following:

- Talent/staffing updates
 - RBH = 97% hired (1 open role K lead teacher)
 - AES = 91% hired (1.5 open roles Paraprofessional & shared security guard)
 - RMS = 82% hired (2.5 open roles Science, DL teacher & shared security guard)
- Enrollment & enrollment verification
 - o RBH = 204
 - o AES = 117
 - o RMS = 105
- Attendance updates
 - o RBH = 87%
 - o AES = 80%
 - o RMS = 78%

7. Treasurer's Report

Board Treasurer, S. Ataya, reported on the following and a full report was shared in the board packet

- YTD financial overview
 - Financial challenges due to enrollment shortfall, unexpected maintenance costs, and spend on subcontracted labor
 - o Delayed title funding from the state
 - o Draw down of Avondale ESSER funding by end of fiscal year
- February YTD report
- FY24 tax engagement with Marcum LLP

8. FY25 Budget Review and Approval

ReGen CFO, B. Chambers, reported on the Ohio FY25 budget with an overview and individual school highlights shared in the board packet.

- Balanced budget, before contingency, for all OH campuses in FY25
- \$330K in year 2 CSP funding
- Pass through grant to RMS
- 37% increase in enrollment
- 4.9% average staff salary increase
- Converting some stipends to salary
- Adding student enrichment

M. Wallace made a motion to approve and adopt the FY25 budget for ReGeneration Bond Hill, ReGeneration Avondale and ReGeneration Middle School's monthly enrollment verification.
